CONTRACT AND DEPOSIT

This contract must be completed and submitted with a \$100 deposit before wedding appointments are booked and/or reserved. Once submitted, our coordinator will work with you to schedule your appointments. We want you to feel as comfortable as possible, so please feel free to contact us at any time with any questions or concerns you may have in regard to your wedding appointments.

DAY OF PAYMENT

On the day of the wedding, the \$100 deposit will be applied to your service total. The remainder of your service total will be due before the bridal party leaves the salon or before our stylist/makeup artist leaves an onsite location. This balance may be increased if additional services are added. Acceptable forms of wedding day payment are cash or credit card. The bride assumes the responsibility of payment for services in full for all members of her party. Gratuities are not included for in salon services. A 15-20% gratuity is traditionally given for any service.

LATE ARRIVALS/NO SHOWS

If anyone in the wedding party arrives more than 15 minutes late, we may not be able to perform their service. If the original contract cannot be fulfilled due to the client's tardiness, services may be cut short, if done at all. However, the original amount will still be owed. If any part of the wedding party has a change of heart or fails to arrive for their appointment, the bride will be charged for the original agreed number of services booked.

CANCELLATIONS

If cancellations are made more than 30 days prior to the event date, the \$100 deposit will be applied to the bride's account and can be used towards any products or services offered in the salon. Cancellations with less than a 30 day notice will forfeit the entire \$100 deposit.

FOR ON-SITE EVENTS ONLY

If the location of any ON-SITE services is within a 30-mile radius of the salon, a \$50.00 on-site mileage charge will be charged for every stylist/makeup artist used for the day-of. An additional \$1.00 will be applied for every mile outside of the specified area. (Example: If one stylist and one makeup artist are needed and the location they are needed at is less than 30 miles away from the salon, a \$100.00 fee will be collected on the day of the wedding.)
